APWA's National Awards Program recognizes outstanding individuals, groups and Chapters representing the best in the public works profession. Hundreds of submissions from throughout the United States and Canada are evaluated in over 25 categories. And the competition is very tough. Each year the APWA National Awards Review Committees receives hundreds of nominations, 2021 was no exception.

The New England Chapter has a tradition of being recognized for our public works achievements. The 2021 APWA National Awards Program proved to be another very successful year for the New England Chapter. This year the Chapter nominated 19 worthy award candidates that resulted in earning another nine National Awards.

The New England Chapter has consistently received National

recognition for the achievements of our members and the public works profession. Collectively the New England Chapter has earned a record 80 national awards within the last seven years: one the most of any of APWA's 63 Chapters throughout the United States and Canada.

As part of an ongoing New England Chapter tradition the Chapter recognizes our National and Chapter Award winners at our National Public Works Week luncheon and at the New England Chapter Summer Conference Awards Banquet. Due to COVID restrictions the Chapter has had to postpone our award ceremonies in 2020 and 2021. The event will

## John Lawlor Bridge Dedication

#### **Press Release**



On September 17, 2021, Bridge No. 01076 in Waterbury, CT was dedicated to Brigadier General John P. Lawlor, Jr. in honor of his 34 years of military service.

BG Lawlor, a member of New England APWA who currently holds a position on the Board of Directors, was commissioned as a Second Lieutenant of Infantry in 1987. His assignments include participating in a task force in Sarajevo Bosnia-Herzegovina, as well as serving as Public Works Team Chief during Operation Iraqi Freedom. BG Lawlor is a proud member of the Military Order of Cincinnatus Society and recipient of the Winfield Scott Medal in recognition of his significant

contributions to the profession of arms and the advancement of the Civil Affairs Branch.

His awards and decorations include the Legion of Merit with two oakleaf clusters, Bronze Star Medal, Defense Meritorious Service Medal. Meritorious Service Medal with oakleaf cluster, Army Commendation Medal with three oak-leaf clusters, Joint Service Achievement Medal. Army Achievement Medal with three oak-leaf clusters, National Defense Service Medal with service star, Armed Forces Expeditionary Medal, Global Terrorism Expeditionary War on Medal, Overseas Service Ribbon, NATO Service Meal, Joint Meritorious Unit Award, Meritorious Unit Award, Army Superior Unit Award, Combat Action Badge, Expert Infantryman Badge, Ranger Tab, Master Parachutist Badge and Air Assault Badge.

The Bridge, which carries Interstate 84 eastbound over Route 70 in Waterbury, will now be known as Brigadier General John P. Lawlor, Jr. Bridge. Carlo Leone, special adviser to the

commissioner of the Connecticut Department of Transportation, invited Lawlor to unveil the metal sign bearing his name that will be affixed to the bridge.

"It's very unusual to have an award or a naming of a bridge or roadway for a living person," Leone said. "Always in the past, it has been as a memorial to someone who has passed away and their past achievements."

Lawlor, who was raised in Waterbury and now lives in Southington with his wife, Natalie, is a rarity in another way. He's among the less than one-tenth of 1% of enlisted men who rise to the rank of Brigadier General.

"While it has never been my goal to be recognized in this way, it has always been my goal to serve others, especially those closest to me," Lawlor said. "It is my family, my friends, my co-workers and my community that have provided me the support and inspiration over the years in order that I could reach such a pinnacle."



## New England Chapter Connects

#### **From APWA Reporter**

It was an undertaking conceived out of necessity. As the COVID-19 pandemic first became a reality in North America last spring, it quickly became apparent that things were going to change for the 63 chapters in APWA.

It was obvious that chapters were not going to be able to offer the traditional educational and training opportunities. In-person meetings were curtailed and that would certainly have an impact on engagement.

What was a chapter to do? How could a chapter stay in touch with its members and make sure the membership at least had the same level of value?

Many chapters embraced the virtual meetings. (video) Some offered educational opportunities through a conference, and others promoted the online resources available through the APWA website. The New England Chapter got busy. Through its Public Works Awareness Committee, which works to promote the value and importance of public works in communities, the chapter developed the New England Chapter Connects Virtual Learning Series.

The goal of the program was developed to keep the members of the chapter engaged, informed, and most important during these uncertain timesconnected. The first session was held in May 2020.

Working with the University of Connecticut T2 Center and the chapter's Education Committee, the New England Chapter Connects program has provided valuable and interesting topics from a variety of distinguished speakers and panel groups. The collaboration with the New England Chapter and the T2 Center at UCONN was very important to the overall success of the program. The program is held at the same time

every month (4th Thursday at 11 a.m.) and lasts only one hour.

"That was important", said Rich Benevento, the chair of the Public Works Awareness Committee for the New England Chapter. "Our members can look at that and devote one hour a month and get some valuable information on a variety of topics and from speakers they might not normally have access to."

This also provided an opportunity to include members from areas of the chapter that normally would drive into the Boston area to attend chapter events or a monthly education meeting.

"We also had members from other chapters, and from as far away as California, Colorado, Michigan and even Puerto Rico," Benevento said.

The program offered a great opportunity for public works professionals to learn, collaborate and exchange ideas. The sessions are free and open to anyone. The program has become a very popular monthly event for the New England members and the participant registrations continue to increase each month. It has provided an opportunity for members to hear from panelists and subject matter experts.

The January 2021 session, 'Selling Your Department's Budget to Elected Officials and the Public," had more than 140 registered. Panelists included the Mayor of Montpelier, VT, a

Finance Director from Connecticut, and a Public Works Director from New Hampshire and Rhode Island talking about how to "sell" the public works department's budget and the discussion was moderated by a Board of Education Finance Director. The panel provided a diverse approach with new ideas for the listeners.

There were experts to talk to those in attendance on hurricane preparedness. Another was on marketing the public works department, to citizens, to elected officials AND to the other members in the department.

"We had panelists who could bring new information," Benevento said.

Some of the sessions were subjectmatter specific, such as "Managing Winter Operations during COVID-19" where the Directors of Operations and Maintenance from all of the chapter's State DOTs spoke, and the March event: "Planning for National Public Works Week and Beyond."

"A lot of our members never have had the opportunity to hear from these types of experts," Benevento added.

Other APWA chapters could offer the same type of information to their members.

Benevento lauded the work of the chapter's Public Works Awareness (PWAC), Education Committee and the Connecticut T2 Center, that made this idea into a real event in a very short time.

#### Will this continue?

"New England Connects will endure post-COVID," Benevento said. "It has become a placeholder on our members' calendars. We think it may have an ongoing presence in the PWAC outreach toolkit beyond the pandemic."

## Muddy Brook Culvert Replacement By Lisa Schaeffler,

The City of South Burlington, in cooperation with the Town of Williston VT, constructed a new arch culvert that will span the Muddy Brook that bisects the City of South Burlington and the Town of Williston. The new arch culvert will replace the 150-ft temporary Maybe bridge that was installed after the existing metal

culvert was damaged in a 2017 storm, and further damaged in the Halloween storm of 2019. The new arch culvert will be 70-ft long. The new road will be 30-ft wide from curb to curb, and there will also be a new 10-ft wide shared use path connecting the City and the Town of Williston. New drainage and miscellaneous utility upgrades are also included as part of the project.



## Managing Town-wide Bridge & Culvert Infrastructure

TEC and the Town of Boxford DPW recently formed a partnership to address townwide bridge and culvert infrastructure. When Chris Olbrot, PE became the new DPW Superintendent and Town Engineer in July of 2019; he made managing his infrastructure assets a top priority. He knew from the massive, 20-year old 3-ring binders of previous field reports that he had well over 200 bridge and culverts throughout his rural community. TEC's structural engineers assisted DPW by putting boots on the ground to locate, inspect and assess 231 culverts and 6 bridges over a 2 month period. The inventory was GIS mapped, data tabulated and an asset management plan was put in place. The plan identified seven (7) culverts requiring immediate action, one of which failed in the summer of 2021. Using the asset management plan, the DPW was ready to respond with a temporary action plan with minimal inconvenience to the public and a permanent solution at this culvert location. Boxford's DPW and TEC continue to progress a capital improvement plan that will address Boxford's road, bridge and culvert infrastructure assets over the next 5 to 10 year period.

## Della Donahue Featured in Boston Architectural College Alumni Profile



Della Donahue, an architect with Weston & Sampson, was recently featured in an alumni profile from the Boston Architectural College, where she completed her Master of Design Studies in Sustainable Design in May of this year.

In the profile, Della credits her childhood awareness of our consumption and waste as humans for inspiring her to write her thesis on "The Department of Public Works and its Unique Leverage to Steward Municipal Sustainability." She now uses her twin passions for design and the environment to make municipal DPW facilities more resilient and sustainable.

Operationally, she illustrates how municipalities do not have to recreate the wheel for stewarding sustainability – every city and town has a Department of Public Works and each one has an inherent connection to environmentalism and the capability to model the way. As for public works facilities, many buildings and yards are due for updates and modernization. Della's thesis proposed a model green DPW facility that takes into consideration dozens of sustainable initiatives, allowing the client to select from a menu of design choices for their new facility.
