President's Message



Happy Holidays, Merry Christmas, and Happy New Year to all!

et me begin by stating that it has been an honor and privilege to serve the New England Chapter of the American Public Works Association as your president the past year. A member since 1996, involved with the Executive Board since 2008, I did my best to carry on the professionalism and traditions of this great organization. Many before me have guided this Chapter since its inception (it will be 70 years in 2024); I am just one person in the long line of past presidents and leaders. I have been lucky enough to call many of them mentors and friends throughout my career, even a few co-conspirators on occasion.

With the new year upon us, we should reflect on the past to learn and prepare for our future. What did we do and what did we accomplish in 2023? We held our monthly Executive Committee meetings using a combination of Zoom, MS Teams, and face-to-face

when the opportunity allowed at the Spring, Summer, and Fall Conferences as well as at our Holiday Gathering on December 2nd in Plymouth, MA.

Our Spring Conference was held in April at Rentschler Field in East Hartford and totaled over 130 attendees, a very successful conference for our Chapter. As we explore opportunities for the future, we have established a Program Committee to plan our conferences and events over the next several years, similar to National APWA. The role of the Program Committee is to identify new locations that meet our needs and to spread our wings in New England. The committee is getting up to speed and identifying locations for the Summer Conference in 2025 as a first initiative. As you may recall, the Sea Crest Resort in Falmouth was the site of our 2023 Summer Conference for the first time since we moved from the Red Jacket. We recently learned that the Sea Crest is booked for 2025 and the Program Committee will be searching for new venues. They issued an RFP to several new locations in New England and will be reporting to the Executive Committee in Jan/Feb. with options for 2025. The RFP identifies all of the usual Summer Conference activities for gathering our group, 100+ hotel rooms, concurrent education sessions, corn hole tournament, clam bake and/or member of the year banquet, executive committee meeting, and other social event space for dinner and entertainment. Our program committee will identify more long-term locations for planning chapter events and activities over multiple years.

Shortly after the Spring Conference, we held our Vermont Municipal Equipment Show and Field Day (VMESFD) with over 550 attendees in Barre, VT. The VMESFD Committee put together a great day to showcase Public Works. For the second year in a row, this event has been so successful that follow-on events have been scheduled and held in the area to continue to promote the benefits of becoming a member of the

chapter. The follow-on NW Committee Event was originally scheduled for July but was postponed and held later in the year as communities dealt with the significant rainfall events that impacted Vermont between July 7-21. Much of that region and other parts of Vermont were severely impacted by significant rainfall events in July which received a disaster declaration from President Biden, allowing Federal Emergency Management Funds to be used to "...provide assistance to survivors of the storms for damage caused during those dates." It is no longer an accepted practice to discuss 100-year storm events. The past several years have experienced storm events that have exceeded that prior benchmark dictated by climate change, requiring a new measurement stick. In closing, we anticipate our Chapter will continue to utilize Zoom and/ or MS Teams communications for many of our Executive Committee Meetings in 2024. While face to face is best for collaboration, Zoom and MS Teams save significantly on food and travel costs as well as rental space for our meetings. Our chapter has been hovering around 1,000 members the past few years but we could always use more support and participation for the Chapter. 

Clay Major Receives Professional Manager of the Year Award in Facilities and Grounds

This August 28th, 2023 in San Diego, California, the American Public Works Association presented the Town of South Windsor Director of Facilities Clayton (Clay) Major with their Professional Manager of the Year Award in Facilities and Grounds. The purpose of this award is to recognize outstanding achievements in the area of facilities and grounds management within the public works field, and to inspire excellence, leadership and dedication to the public good. This recognition is on a national level in consideration of nearly 20,000 communities throughout the United States.

Mr. Major's experiences encompass not only local government administration, but the private sector as well with a career in facilities management that has spanned over three decades. During this time, Clay developed a unique perspective and insight of the building maintenance and management industry. This familiarity and level of expertise allowed him to make indelible impacts on the public works community.

An exemplification of these impacts to the Building Maintenance community is Clay's initiative creating a statewide Facility Listserve exchange program where local leaders in the industry can collaborate on a variety of issues and share solutions. Another template of success Clay created was hosting industry roundtables where many timely issues are discussed in a collaborative arena, resulting in solutions that may not have been found without the creative space of a round table.

Some local impacts resulting from Mr. Major's work include leveraging technology to create a safer, simpler work place for employees and residents alike. This has included installing card readers in all the Town buildings to create 'keyless' door system and leveraging relationships with local utility suppliers and partnering in unique ways to keep the cost of energy consumption down. Most recently, with the lighting upgrades and HVAC improvements underway, he is not only saving local tax payers money, but improving the environment as a whole for all employees and residents.

In addition to these initiatives, Clay has also been an integral piece in an array of programs; be it physically transferring whole departments of the Town between buildings, responding to the COVID emergency with physical elements Town-wide to keep residents and employees safe alike, or providing support during seasonal emergency storm responses.

This recognition of excellence from APWA is a testament to Mr. Major's professionalism and commitment to excellence and progress in the public works building maintenance industry. A consummate professional, Clay is a well-respected team member, excellent father, and friend to many. Please share in our congratulations to Clay. These WRAPs contrast planning methodologies between an urbanized 2-square-mile watershed with a history of frequent and high-impact flooding within Environmental Justice areas in Methuen and Lawrence versus an undeveloped 26-square-mile watershed with a flooding history that poses risks to aging infrastructure (dams, roads, buildings). The plans also provide a framework for identifying and advancing infrastructure replacement projects through existing infrastructure funding programs.

collaboration between municipal stormwater or floodplain managers and public works department to identify these projects, tap into state and federal funding opportunities, and design projects that improve public parks, playgrounds, athletic fields, and other recreational amenities for residents, while also reducing stormwater runoff, improving water quality, and increasing community resiliency. Some project examples include new athletic facilities for a Massachusetts school that incorporated design details to reduce flood frequency or

resolving combined sewer overflow by installing storage tanks adjacent to a popular bayside trail in Maine and restoring recreational fields to minimize future flooding in the process.
