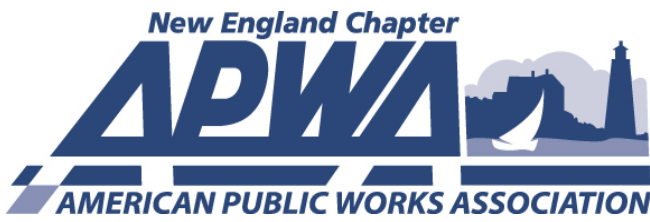

8. Award winner shall become a member of New England APWA for a minimum of one (1) year within six (6) months of notice of the award and prior to receiving any funds. Proof of membership shall also be provided for reimbursement.

This year's PWX Scholarship will be announced after all applications have been reviewed by the Chapter's Scholarship Committee. Scholarship funds will be provided for airfare, hotel, and conference registration as a reimbursement.
